

# Frequently Asked Questions (FAQ)

## Research Study for online survey

### (Quantitative Research)

#### **1. What is the purpose of this study?**

This study aims to explore the lived experiences of women working in the Northern Territory (NT) mining industry. Women remain under-represented in mining compared to the national average, despite the industry being one of the highest-paying and economically significant sectors. By hearing directly from women, we hope to better understand barriers, opportunities and ways to improve workplace culture, gender equality and safety.

#### **2. Why have I been invited to take part?**

You are invited if you identify as a woman currently working in any role on an NT mine site. Your experience is important for understanding both challenges and opportunities in the sector.

#### **3. What will I be asked to do?**

You will be invited to voluntarily complete an anonymous online survey, which should take about 10-15 minutes. The Questions focus on:

- Your role, work conditions and employment type
- Training, leadership and career opportunities
- Workplace culture and inclusion
- Health, safety and psychological wellbeing
- Awareness of reporting and support systems

#### **4. Do I have to participate?**

No. Participation is voluntary. You may stop or skip questions at any time. Once submitted, responses are anonymous and cannot be withdrawn individually.

#### **5. Are there any risks?**

Risks are low. Some questions may raise sensitive issues (e.g. discrimination or harassment). You can skip questions or exit the survey at any point. Support service contacts are provided.

#### **6. Will my answers be de-identified?**

Yes. The survey does not collect names or identifying details. Results are combined and reported only in summary form. Employers will not see individual responses or receive your personal data.

#### **7. How will my information be used?**

Survey data will be analysed and included in a final report. The report will be shared publicly via [www.unionsnt.com.au](http://www.unionsnt.com.au) and with key stakeholders such as government, unions and industry leaders to inform strategies for gender equality.

## **8. What are the benefits of participating?**

By taking part, you help build evidence for safer, fairer, and more inclusive workplaces in the NT mining industry. The findings can influence workplace culture, policies and future opportunities for women.

## **9. What happens to the data collected?**

All responses are securely stored, de-identified and analysed in line with ethical guidelines. No one will be able to identify you or your workplace.

## **10. Who is conducting the study?**

The study is facilitated by Unions NT and delivered by the Gender Equality Project Team. This research received grant funding from the Australian Government.

## **11. What ethical approval does the study have?**

The project has been reviewed and cleared by a Human Research Ethics Committee, ensuring it meets national standards for ethical research.
